1 MEMORANDUM OF POINTS AND AUTHORITIES

2 I.

3 ARGUMENT

4 Mr. Jackson objects to the Prosecution's untimely designation of an entertainment
5 industry financial expert. Having said that, Mr. Jackson does not oppose the admission of
6 the testimony of the Prosecution's forensic accountant, [REDACTED], and an
7 entertainment industry financial expert (yet to be designated), so long as:

- 8 1. The Defense is timely provided with these experts' opinions and conclusions:
9 2. The Defense is furnished with all of the materials and documents upon which
10 these experts based their opinions and conclusions;
11 3. The Defense is afforded reasonable time (e.g., 2 weeks) to find its rebuttal
12 experts;
13 4. The Defense is given reasonable time (e.g., 3 weeks from the time the experts
14 are found) for its rebuttal experts to reach their opinions and conclusions

15 Absent these conditions, the Motion should be denied.
