MEMORANDUM OF POINTS AND AUTHORITIES

Under California Rule of Court 243.2, "[a] record must not be filed under seal without a court order." Motions and responsive pleadings in criminal cases are, ordinarily, "public" records of the court.

Rule 243.1(d) provides that

The court may order that a record be filed under seal only if it expressly finds facts that establish:

- There exists an overriding interest that overcomes the right of (1)public access to the record;
- The overriding interest supports sealing the record; (2)
- A substantial probability exists that the overriding interest will be (3) prejudiced if the record is not sealed;
- The proposed sealing is narrowly tailored; and (4)
- No less restrictive means exist to achieve the overriding interest. (5)

Rule 243.1(e) provides, in pertinent part:

An order sealing the record must (i) specifically set forth the facts, (1)findings that support the findings and (ii) direct the sealing of only those documents and pages, or, if reasonably practicable, portions of those documents and pages, that contain the material that needs to be placed under seal. All other portions of each document or page must be included in the public file.

Rule 243.2(b) provides in pertinent part that "pending the determination of the motion [of a party to file a record under seal], the lodged record will be conditionally under seal."

In its July 9 Order, the Court has already determined that papers such as those sought to be filed under seal here should be so filed. Furthermore the facts of, and intense public
