
18 I, Mag M. Nicola, Sr. Deputy District Attorney of the County of Santa Barbara, State of  
19 California, declare under penalty of perjury that the following is true and correct:

20 That there is now pending in the Superior Court, Department 8, City of Santa Maria, a  
21 criminal action against MICHAEL JOE JACKSON, charging said defendant with violation of  
22 Section 288(a) of the Penal Code. On April 18, 2005, this court issued an order directing that  
23 witness CHRISTOPHER CARTER, [REDACTED] be temporarily released by  
24 SANTA BARBARA COUNTY JAIL for the purpose of appearing before the above mentioned  
25 court on APRIL 22, 2005, at 8:30 A.M. and at such other times as may be ordered by the court.

26 In the interest of maintaining a smooth and continuous flow of witnesses in the matter now  
27 pending, affiant therefore prays that a MODIFIED order issue for the temporary release of said

1 prisoner and for an order that he be "dressed-out" in civilian clothing and directing the Sheriff of  
2 Santa Barbara County to transport said CHRISTOPHER CARTER and produce him before the  
3 aforementioned Court in the County of Santa Barbara **AT ANY TIME BETWEEN APRIL 20**  
4 **AND APRIL 22, 2005**, and upon completion of said proceedings to RETURN the said  
5 CHRISTOPHER CARTER to SANTA BARBARA COUNTY JAIL.


