

2 **RELEVANT FACTS**

3 On April 9, 2004 the Court filed its "Order on Reconsideration of Work Product
4 Issues." The effect of the Order was stayed for a period of 15 days. (Order at 3:3-5.) Mr.
5 Jackson intends to timely seek writ relief from the Order. The requested transcripts are
6 necessary for the defense's (and appellate court's) review. However, during the in
7 camera proceedings, the Court ordered that they not be transcribed absent an order of the
8 Court. As such, Mr. Jackson respectfully requests that the court order expedited
9 preparation of the transcripts.
