Counsel present for the Media is Theodore Boutrous.

Counsel Edgar Pease is present for Henry Vaccaro Jr., Vintage Pop, Elmer Kendrick, El-Rich Corp., Henry Vaccaro and Deep End Entertainment who are Co-Defendants in Federal Civil Actions.

Attorneys Plumer, Pease and Sanger addressed the Court re: Motion by Owners for Return of Personal Property.

Attorneys Sanger and Boutrous addressed the Court re: Access Proponents' Motion to Unseal All Court Records Sealed Prior to Commencement of Trial. The Court orders that the motion shall be granted except for hearings re: Jurors that were held In Camera that involve some privacy rights; that as to personal identifying information, the sealing order shall continue to be followed; that the Defendant shall identify all areas they are requesting to remain sealed; that Counsel shall have until June 23, 2005 to notify the Court of any documents they are requesting to remain sealed; that the Court shall attempt to complete the unsealing procedure within thirty days from today.

The Court finds that the Access Proponents' Request for Immediate Release of Blank Verdict Forms is moot.

Attorney Boutrous addressed the Court re: Access Proponents' Request for Immediate Public Access to Written Questions from the Jury. The Court orders that the motion shall be granted with immediate release of questions.

Attorneys Boutrous and Sanger addressed the Court re: Access proponents' Request for Immediate Release of In Camera Transcript. The Court finds that there was not an In Camera hearing held on May 23, 2005.

The Court further orders that exhibits may be viewed, but not copied; that the exhibits shall be returned to the parties who entered them upon the formal request in writing by the appropriate Counsel.

Attorney Boutrous asked the Court if he can copy video tapes played in Court. The Court shall make a ruling on the request; that Points and Authorities shall be filed by Attorney Boutrous by June 23, 2005 and by Attorney Sanger by June 27, 2005; that a stipulation to return the exhibits shall not be signed prior to Attorney Boutrous' points and authorities being considered.

The Court is not determining the ownership of the materials by returning any items to Counsel.

The Court orders that Michael Jackson's passport shall be returned to him. The Court believes that said passport is in the possession of the Santa Barbara County Sheriff.
