Indictment filed April 21, 2004 charging the Defendant with Count 1: 182 P.C., a Felony, Counts 2 through 5: 288(a) P.C., Felonies, Count 6: 664/288(a) P.C., a Felony, Counts 7 through 10: 222 P.C., Felonies, Special Allegations on Counts 2 through 5: 1192.7(c)(6) P.C. and 1203.066(a)(8) P.C.

**The Court made orders re: In Camera Hearing Issues, Continuance of In Camera Hearing**

Counsel present for the Defendant are Thomas A. Mesereau, Jr., Robert M. Sanger and Susan Yu.

A 977 Waiver is on file and the Defendant's presence is excused for this hearing.

At 2:35 P.M. with Court, Research Attorney Jed Beebe, and Counsel for the Defendant and Attorney for John Doe's Father present, in the absence of the District Attorney, the Court held an in camera hearing.

Attorney for John Doe's Father addressed the Court re: certain issues regarding his client. Attorney for John Doe's Father was excused from the remainder of the in camera hearing.

Attorney Mesereau addressed the Court re: certain issues as to subpoenaed records.

At 3:05 P.M. with Court, Research Attorney Jed Beebe, Counsel for the Defendant, Counsel for subpoenaed party present in Court and Counsel for Mrs. Doe present by phone, hearing continued.

Counsel further addressed the Court re: certain issues as to subpoenaed records.

The Court further orders that the file shall be made available to Attorney for Mrs. Doe; that said Attorney shall go to Counsel for subpoenaed party's office to review the file, make a log of items claimed as attorney-client privilege by December 9, 2004 and convey it to the Court by 3:00 P.M. on December 9, 2004; that the privilege log shall be filed under seal and FAXed directly to the Judge's FAX machine.

Attorney Oxman shall submit further Points and Authorities to the Court re: the issue of attorney-client privilege by December 3, 2004 and Attorney for Mrs. Doe shall reply by December 9, 2004. Attorney for Mrs. Doe may involve the District Attorney and she shall serve the District Attorney with a copy of her Points and Authorities; that Attorney Oxman shall serve the District Attorney with his Points and Authorities; that the District Attorney may respond.

The Court further orders that an in camera hearing shall be held on December 22, 2004 at 1:30 P.M. regarding said certain records; that Mrs. Doe's Attorney may discuss this issue with the District Attorney.

The Court further orders that the Reporter's transcript of the in camera hearing shall be sealed pursuant to the protective order and findings previously made by the Court and shall not be transcribed without further order of the Court.


