RESPONSE OF THE ACCESS PROPONENTS TO DEFENDANT'S CONSOLIDATED RESPONSE TO (I) ACCESS PROPONENTS'
OPPOSITION TO SEALING OF RECORDS RELATED TO COMPUTER HARD-DRIVES SEARCH WARRANT; (II) ACCESS PROPONENTS'
OPPOSITION TO SEALING OF RECORDS RELATED TO SEVEN TELEPHONE SERVICE PROVIDERS SEARCH WARRANTS; (III)
PLAINTIFF'S MOTION TO SEAL RECORDS RELATING TO SEARCH WARRANT NO. SW 4912

1 The Access Proponents¹ respectfully submit that this Court should reject, as it did at the
2 January 16 hearing, Defendant Jackson's request for "a subsequent briefing schedule and [delayed]
3 hearing" on the various motions to seal that the District Attorney has filed and that the Access
4 Proponents have opposed. Defendant Jackson and his lawyers have known full well for over *three*
5 weeks that the District Attorney is seeking to file under seal certain records relating to the search of
6 Bradley Miller's office, for over *two* weeks that the District Attorney is seeking to file under seal
7 certain records relating to the seven search warrants directed at telephone service providers, and for
8 almost *one* week that the District Attorney is seeking to file under seal certain records relating to the
9 search of certain hard drives on computers seized from Jackson's Neverland Ranch and to Search
10 Warrants Nos. 4912 and 4915. And they were served by fax and by mail with the Access
11 Proponents' formal Oppositions to all but the last two of the foregoing sealing requests² last Friday
12 and this past Monday. Yet Defendant Jackson's lawyers did not bother to file their plea for more
13 time in which to review these conditionally sealed records and to brief the merits of disclosing or
14 releasing same until less than a day and half before the hearing scheduled by this Court to consider
15 the merits of these sealing requests.³

16 Defendant Jackson's lawyers have had ample time in which to request an in-camera review of
17 the materials that have been conditionally filed under seal and the continued sealing of which this
18 Court has set to be heard this Friday, February 13. Consequently, this Court should reject their

22 ² The Access Proponents' Oppositions to the District Attorney's motions to seal the records
23 relating to Search Warrants Nos. 4912 and 4915 were served on Defendant Jackson's lawyers by
24 fax and by mail on February 11, 2004, since the District Attorney's motions to seal these records
were not served on the Access Proponents nor were they made available on the Court's website
until the afternoon of February 10, 2004.

25 ³ Although Defendant Jackson's Consolidated Response was directed principally at the Access
26 Proponents' formal Oppositions, none of Defendant Jackson's lawyers bothered to serve the
27 Access Proponents' counsel of record with said Consolidated Response. The Access Proponents
28 respectfully submit that henceforth, any further motions to seal and any other filings implicating
the public's and the media's right of access to these proceedings should be served on the Access
Proponents' counsel of record.

1 attempt to indefinitely delay the resolution of the public's claims of access to these records, which are
2 grounded in the First Amendment to the United States Constitution, Article I, Section 2 of the
3 California Constitution, Penal Code § 1534(a), the common law, and California Rules of Court 243.1
4 and 243.2.


