1 Please take notice that the Defendant does hereby move and will further move on a date
2 determined by the Court, at 8:30 a.m., or as soon thereafter as counsel may be heard in Department
3 8 of the above entitled court, for an order quashing the subpoena duces tecum served on served on
4 Holthouse Carlin & Van Trigt on February 3, 2005, or, in the alternative, issue a protective order
5 declaring that the subpoenaed records are inadmissible at trial, must be returned to the subpoenaed
6 party, and that all copies in the possession of the District Attorney or law enforcement must be
7 destroyed, and for such other relief as the Court may deem just and proper, and Defendant moves
8 for an immediate stay of said subpoena until this motion can be heard on the merits. Counsel for Mr.
9 Jackson have recently been made aware that the District Attorney has served a subpoena duces tecum
10 on Holthouse Carlin & Van Trigt seeking Mr. Jackson's financial records. Mr. Jackson was not
11 served with a copy of the subpoena.

12 The grounds for this motion are set forth in the attached Memorandum of Points and
13 Authorities, including:

- 14 1. The subpoena must be quashed because it fails to establish good cause for production of the
15 subpoenaed documents.
- 16 2. The subpoena duces tecum constitutes an invasion of Mr. Jackson's right to privacy pursuant
17 to the United States Constitution and Article 1, Section 1, of the California Constitution.
- 18 3. The subpoena seeks information that can only be lawfully obtained through the statutory
19 discovery process outlined in Penal Code Section 1054 *et seq.*
- 20 4. The subpoena is overbroad and seeks information that would compromise trade secrets,
21 would interfere with contracts and would interfere with prospective advantage.



DECLARATION OF ROBERT M. SANGER

I, Robert M. Sanger, declare:

1. I am an attorney at law duly licensed to practice law in the courts of the State of California, a partner in the law firm of Sanger & Swysen, and co-counsel for Michael Jackson.

2. The court ruled, on January 28, 2005, that the District Attorney cannot use detailed financial evidence to show motive.

3. None of these materials are relevant to the charges against Mr. Jackson. As argued in Mr. Jackson's Opposition to District Attorney's Motion in Limine for Admission of Expert Testimony on Defendant's Finances, and Mr. Jackson's Motion in Limine to Exclude Any Reference to Mr. Jackson's Financial Status, evidence that Mr. Jackson was financially distressed or in debt is inadmissible to show a motive to commit a crime for financial gain.

4. Furthermore, there is no showing that the materials could corroborate the stories told by the complaining witnesses. The charged offenses are child molestation and a conspiracy to commit false imprisonment, extortion and child abduction. Mr. Jackson's financial holdings or evidence of potential entertainment contracts are not relevant to these charges under any admissible theory.

5. Mr. Jackson is an international recording artist and a man who has varied and complex business relationships with numerous individuals and entities. The very nature of these types of business relationships is that the parties honor a commitment to their respective privacy. Matters that are totally irrelevant to this case would be disclosed by compliance with this subpoena which have been kept confidential. Disclosure would not only compromise the confidentiality of existing contracts, but would unfairly restrict Mr. Jackson's ability to enter into pending and future contracts in the entertainment industry.


6. The District Attorney is seeking materials that includes information regarding entertainment industry deals including business contracts, licensing agreements, royalty payments, and other information that is confidential.

1 MEMORANDUM OF POINTS AND AUTHORITIES

2 I.

3 THE SUBPOENA SHOULD BE QUASHED BECAUSE IT FAILS TO ESTABLISH
4 GOOD CAUSE

5 The subpoena must be quashed because it fails to satisfy the requirements of Code of
6 Civil Procedure 1985 or otherwise to establish with sufficient particularity that there is good
7 cause for production of the subpoenaed documents. The District Attorney is seeking to obtain
8 documents to "prove motive on behalf of defendant for the charged offenses and to corroborate
9 the victims of the charged offenses." (Affidavit, page 2.) On this basis, the District Attorney
10 seeks:

11 Statement of Assets and Liabilities as of 12/31/99, 12/31/00, 12/31/01, 12/31/02
12 and through termination. Statement of Revenues and Liabilities as of 12/31/00,
13 12/31/01, 12/31/02 and through termination. Balances for all Asset, Liability and
14 Equity accounts as of 12/31/99, 12/31/00, 12/31/01, 12/31/02 and through
15 termination. Accounts payable Check Registers, in detail by vendor, for the 2000,
16 2001 and 2002 calendar years, and through termination. Unpaid Accounts
17 Payable and Accrued Liabilities Balances, in detail by vendor, as of 12/31/99,
18 12/31/00, 12/31/01, 12/31/02 and through termination. Bank statements for all
active deposit, collection and loan collateral accounts, as of 12/31/99, 12/31/00,
12/31/01, 12/31/02 and through termination. Periodic statements reporting music
publishing activity related to the Sony/ATV and MIJAC catalogs, including
statements received from 12/31/99 through termination. Reports or statements
providing evidence of value for any music publishing catalogs, real estate or other
real property, received from 12/31/99 through termination.
(Affidavit, page 1.)

19 The court ruled, on January 28, 2005, that the District Attorney cannot use detailed
20 financial evidence to show motive. (Declaration of Robert M. Sanger.) The law is very clear in
21 that regard. Therefore there is not good cause to subpoena these materials.

22 None of these materials are relevant to the charges against Mr. Jackson. As argued in Mr.
23 Jackson's Opposition to District Attorney's Motion in Limine for Admission of Expert
24 Testimony on Defendant's Finances, and Mr. Jackson's Motion in Limine to Exclude Any
25 Reference to Mr. Jackson's Financial Status, evidence that Mr. Jackson was financially distressed
26 or in debt is inadmissible to show a motive to commit a crime for financial gain. (Declaration of
27 Robert M. Sanger.)

NOTICE OF MOTION AND MOTION TO QUASH SUBPOENA TO HOLTHOUSE CARLIN AND VAN TRIGT

1 It is a well-established rule that a defendant's poverty or indebtedness may not be
2 admitted to prove a motive to commit crimes of financial gain. (*People v. Koontz* (2002) 27
3 Cal.4th 1041, 1076, stating that "a defendant's poverty generally may not be admitted to prove a
4 motive to commit a robbery or theft . . ."; *People v. Wilson* (1992) 3 Cal.4th 926, 938-938.,
5 stating that evidence of defendant's debt, admitted for the purpose of establishing a motive to
6 commit robbery and murder, was not admissible on any proper ground.) "[F]or over a century
7 courts have recognized the potential unfairness in admitting such evidence." (*People v. Carrillo*
8 (2004) 119 Cal.App.4th 94, 101.) While there are obvious reasons for the prosecution to want to
9 use a defendant's poverty "to provide a convincing harmony to the factual melody of the crime,"
10 such evidence deprives a defendant of a fair trial and constitutes reversible error. (*People v.*
11 *Carrillo, supra*, 119 Cal.App.4th 94, 97.)

12 Furthermore, there is no showing that the materials could corroborate the stories told by
13 the complaining witnesses. The charged offenses are child molestation and a conspiracy to
14 commit false imprisonment, extortion and child abduction. Mr. Jackson's financial holdings or
15 evidence of potential entertainment contracts are not relevant to these charges under any
16 admissible theory. (Declaration of Robert M. Sanger.)

17 II.

18 THE SUBPOENA THREATENS TO DEPRIVE MR. JACKSON OF HIS RIGHT TO 19 PRIVACY UNDER THE UNITED STATES CONSTITUTION AND CALIFORNIA 20 CONSTITUTION

21 Mr. Jackson will be deprived of his right to privacy pursuant to the United States
22 Constitution and Article I, Section 1, of the California Constitution, if the subpoena duces tecum
23 is not quashed. Records regarding Mr. Jackson's financial affairs are protected by his right to
24 privacy. The District Attorney is prosecuting him for child molestation and conspiracy. As
25 argued above, Mr. Jackson's financial records are not relevant to the charges against him. As
26 such, the prosecution has not demonstrated any interest that justifies invading Mr. Jackson's right
27 to privacy.

1 Mr. Jackson is an international recording artist and a man who has varied and complex
2 business relationships with numerous individuals and entities. The very nature of these types of

8 III.

9 **IF THE DISTRICT ATTORNEY COULD DEMONSTRATE GOOD CAUSE TO**
10 **OBTAIN THIS INFORMATION, IT COULD ONLY BE LAWFULLY OBTAINED**
11 **THROUGH THE STATUTORY DISCOVERY PROCESS**

12 The District Attorney is attempting to obtain what he cannot obtain through the discovery
13 process by a subpoena duces tecum. This is a blatant attempt to obtain documents from Mr.
14 Jackson and to circumvent the statutory scheme enacted by the voters as Penal Code section 1054
15 et seq., which very clearly states that:

16 [N]o discovery shall occur in criminal cases except as provided by this chapter,
17 other express statutory provisions, or as mandated by the Constitution of the
United States. (Penal Code section 1054 (e).)

18 The expressed terms of the statutes state that the prosecutor cannot use the subpoena process to
19 obtain discovery.

20 IV.

21 **THE SUBPOENA IS OVERBROAD AND SEEKS INFORMATION THAT WOULD**
22 **COMPROMISE TRADE SECRETS, INTERFERE WITH CONTRACTS AND**
23 **INTERFERE WITH PROSPECTIVE ADVANTAGE**

24 The District Attorney is seeking materials that includes information regarding
25 entertainment industry deals including business contracts, licensing agreements, royalty
26 payments, and other information that is confidential. The owner of a trade secret has a privilege
27 to refuse to disclose and to prevent others from disclosing trade secrets so long as allowance of

1 the privilege will not tend to conceal fraud or otherwise work an injustice. (Evidence Code
2 Section 1060.) A trade secret is information that: (1) derives independent economic value (actual
3 or potential) from not being generally known to the public or others who can obtain economic
4 value from its disclosure or use; and (2) is the subject of reasonable efforts to maintain its
5 secrecy. (Civil Code of Procedure Section 3426.1(d)(1)&(2).B) The subpoena duces tecum is
6 overbroad and seeks information that is covered by the trade secret privilege. (Declaration of
7 Robert M. Sanger.)

8 V.

9 CONCLUSION

10 Therefore, based on the reasons set forth above, Mr. Jackson requests that the Court
11 quash the subpoena duces tecum, or, in the alternative, issue a protective order declaring that the
12 subpoenaed records are inadmissible at trial, must be returned to the subpoenaed party, and that
13 all copies in the possession of the District Attorney or law enforcement must be destroyed.




