22 Comes now the People of the State of California, Thomas W. Sneddon, Jr.,
23 District Attorney of Santa Barbara County, State of California, and represents and
24 shows:

25 That at the present time there is pending in the Superior Court of the State of
26 California, County of Santa Barbara an action entitled People v. Michael Joe Jackson,
27 Superior Court number 1133603. He is being prosecuted in this jurisdiction for felony
28 offenses and the case is in trial at this time. The above-mentioned subject is now in the
custody of the Clark County Detention Center, Las Vegas, Nevada. His institution

2 To secure the attendance of said CHRISTOPHER ERIC CARTER, [REDACTED]
3 [REDACTED] before our Superior Court for the purpose of giving testimony as soon as practical, it
4 is necessary and proper that a Writ of Habeus Corpus Ad Testificundum be issued
5 commanding Sheriff Bill Young, and the Watch Commander on duty of the Clark
6 County Detention Center to release the said prisoner for transportation to Santa
7 Barbara County Jail to be held therein during the period between and during such
8 normal court proceedings as may take place. After the completion of the testimony of
9 the witness, said subject should then be returned to the aforementioned Clark County
10 Detention Center .

11 WHEREFORE, your petitioner prays for an order directing issuance of a Writ of
12 Habeus Corpus Ad Testificundum out of and under the seal of this Court, directed to
13 Sheriff Bill Young and the Watch Commander, Clark County Detention Center , Las
14 Vegas, Nevada, commanding the said Sheriff and Watch commander, as herein
15 mentioned, to release CHRISTOPHER ERIC CARTER, [REDACTED], INMATE
16 NUMBER [REDACTED] from his place of incarceration in the Clark County Detention
17 Center, to Santa Barbara Sheriff Jim Anderson's designated agent for transportation to
18 the Santa Barbara County Jail where he is to be held between court proceedings in the
19 Superior Court of the State of California, County of Santa Barbara. The witnesses court
20 appearance is set for APRIL 4, 2005 . That on the completion of the testimony of the
21 witness in this jurisdiction, the inmate is to be returned by Sheriff Jim Anderson's
22 designated agent to continue his confinement and processing at the Clark County
23 Detention Center, Las Vegas, Nevada as soon as possible.
