19 "Access Proponents" ("Media") have moved for an order unsealing the grand jury
20 transcript and unredacting the indictment in this matter.

21 Defendant has filed his Opposition to Media's motion, on the ground that disclosure
22 of what amounts to a one-sided view of the case would inevitably contaminate the jury pool
23 and add further fuel to unremitting and sensationalist commentary in the popular press and on
24 television – all to the prejudice of defendant's right to a fair trial.

25 The People wholeheartedly join in defendant's opposition. The jurors in this case
26 should learn about the evidence while seated in the jury box, not at the breakfast table or from
27 late-night talk shows. The Court wisely sealed the transcript and redacted much of the
28 indictment itself. Those records should remain sealed.
