A 977 Waiver is on file and the Defendant's presence is excused for this hearing.

Discussion was held regarding the hard drive issues and the EnCase specialist. The Court advised Counsel of the name of the EnCase specialist that the Court has selected.

The Court orders that the computer hard drives shall be turned over to the selected EnCase specialist on November 24, 2004; that he shall not examine the hard drives until the Court or Special Master gives authorization; that the EnCase specialist shall not share the hard drive material with any law enforcement agency or any person other than the Special Master; that the District Attorney shall pay for any of the specialist's fees that are not otherwise covered.


Attorney Sanger shall prepare the order and submit it to the Court for signature and filing by 10:00 A.M. on November 24, 2004.

Upon stipulation of Counsel for respective parties the Court orders that certain bank records received under subpoena may be copied for both the prosecution and the defense.

The Court further orders that the Reporter's transcript shall be sealed pursuant to the protective order and findings previously made by the Court and shall not be transcribed without further order of the Court.


