21 **IT IS SO ORDERED:**

22 a) That the Motions to Quash the Subpoena of George and Ann Lopez to appear on

24 are QUASHED.

25 **IT IS FURTHER ORDERED:**

28 and Ann Lopez of the intent to resubpoena Mr. and Mrs. Lopez so that the Court and counsel can

2 subpoenas as to why they would need to subpoena both of these individuals. Defense counsel is
3 further instructed to address the specific reasons why they would need to subpoena George Lopez

5 b) At the hearing, counsel for George and Ann Lopez, James E. Blancarte, also
6 indicated his willingness to accept service of further subpoenas.

7 c) The court further indicated that it would take George and Ann Lopez's Request for
8 Attorney's fees under Submission and research the law in that regard. In a discussion between
9 this Honorable Court, Defense Counsel, and Counsel for George Lopez and Ann Lopez, held
10 outside the presence of the Court Reporter the Court agreed to allow counsel for George Lopez
11 and Ann Lopez to submit a supplemental response on the of a attorneys' fees issue only by
12 Friday, February 4, 2005 and that Defense Counsel would be afforded time to prepare a reply.


