19 I, MAG NICOLA, declare as follows:

20 1. That I am a Senior Deputy District Attorney of the County of Santa Barbara,
21 State of California.

22 2. That there is now pending in this jurisdiction in the Superior Court, an action
23 entitled People v. Michael Joe Jackson, Superior Court number 1133603 charging the
24 aforementioned subject with several felony offenses.

25 3. Christopher Eric Carter, [REDACTED] is at the present
26 time incarcerated in the Clark County Detention Center, Las Vegas, Nevada under the
27 direct control and supervision of the Sheriff Bill Young, and the Watch Commander of

2 4. The inmate is needed as a Prosecution witness in the above described felony'
3 case. The assigned District Attorney in the witness' Clark County prosecution, Susan
4 Krisco, has no objection to the transportation order so long as the witness will only be in
5 California for approximately two weeks.

6 5. It is thus necessary and proper that CHRISTOPHER ERIC CARTER be
7 produced as soon as practical before our Superior Court, and that he be transported
8 from the Clark County Detention Center, Las Vegas, Nevada, by Santa Barbara Sheriff
9 Jim Anderson's designated agent Detective Gregg Wilkins and produced here and held
10 here in our county jail between necessary court appearances. Christopher Eric Carter's
11 court appearance is scheduled for April 4, 2005. After completion of his testimony he
12 should be returned to the Clark County Detention Center by Santa Barbara Sheriff Jim
13 Anderson's designated agent .

16 is true and correct.
