On August 13, 2004, Mr. Jackson filed a motion to seal his Request that Michael Jackson Be Permitted to Make Public Statement regarding a television movie entitled "Man in the Mirror." The request was conditionally sealed on August 17, 2004. At the September 16, 2004 hearing, the court indicated that the motion to seal was granted. Upon further consideration, however, the court concludes that the Request should be unsealed.

At the time the request was filed, releasing it in its unredacted form would have defeated the purpose of the "safe harbor" provisions of the protective order. That provision permits the court an opportunity to review proposed statements prior to their release to determine whether the statement violates the protective order. This procedure is designed to protect both parties' right to a fair trial. Thus, conditional sealing of the document was appropriate. However, since the court determined that the statement would not violate the protective order and the statement has been already been made, there is no need for continued sealing.

Absent objection from the parties, the court orders that the Request that Michael Jackson Be Permitted to Make Public Statement be unsealed and placed in the public file on September 27, 2004.
