6 subpoena identified herein as Exhibit 1. That Protective Order states, in part:

7 "3. Persons or entities subpoenaed by the Defendant shall not disclose directly or indirectly to  
8 the People the fact that they have been subpoenaed or the nature of the subpoena.

9 4. Any appearance, objection, compliance, or other communication by a party subpoenaed by  
10 the defendant shall be filed under seal."
