5 grounds that, pursuant to *Johnson v. Superior Court* (1975) 15 Cal.3d 248, *People v. Backus*  
6 (1979) 23 Cal.3d 360, 293, and *Cummiskey v. Superior Court* (1993) 3 Cal.4th 1018, Mr.  
7 Jackson has the right to challenge improprieties in the grand jury process, and transcripts of the  
8 grand jury selection process are necessary to make such a challenge. This motion is further based  
9 on Penal Code Sections 893 and 894.

10 This motion is based on this Notice of Motion, the Memorandum of Points and  
11 Authorities and the Court's papers, records and files in this case and such evidence and other  
12 matters as may be received by the Court at or after the hearing scheduled on this motion.



1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 **I.**

3 **A DEFENDANT MAY CHALLENGE IMPROPRIETIES IN THE GRAND JURY**  
4 **PROCESS**

5 Cases such as *Johnson v. Superior Court* (1975) 15 Cal.3d 248, *People v. Backus* (1979)  
6 23 Cal.3d 360, 293, and *Cummiskey v. Superior Court* (1993) 3 Cal.4th 1018, stand for the  
7 proposition that defendants may challenge inproprieties in the grand jury process. The selection  
8 of the grand jurors, and, in particular, the role of the Court, or if applicable, District Attorney in  
9 the selection process, may provide grounds for such a challenge in the case at bar. Therefore, it  
10 follows that Mr. Jackson has a right to discovery of transcripts of grand jury selection.

11 **II.**

12 **GRAND JURORS CAN ONLY BE EXCUSED ON LIMITED STATUTORY**  
13 **GROUND**

14 Penal Code Sections 893 and 894 provide an exhaustive list of qualifications for  
15 prospective grand jurors. Grand jurors may only be excused from service on these limited  
16 statutory grounds. Therefore, in order to challenge inproprieties in the grand jury process based  
17 on a failure to abide by the statutes Mr. Jackson is entitled to transcripts of the grand jury  
18 selection process. Unless, and until, the defense is provided a transcript of the selection process,  
19 the defense has no basis to evaluate whether or not such a challenge is appropriate.

The Court should order the court reporter to prepare a transcript of the grand jury selection process and provide the transcript to counsel for Mr. Jackson and to the prosecution.


